Membership Application Instructions

Application is form field enabled – Use Adobe Reader to type in the fields

There are three different types of memberships.

- 1st SENIOR** Head of household and/or dependent child 25 years old or older.
- 2nd SENIOR** A spouse and/or dependent child of a 1st Senior member, over 18 years old, but younger than 25 years old.
- JUNIOR** Any resident dependent / family member of a 1st Senior member under the age of 18 years old

Families (2nd Seniors and Juniors) can join at the same time as the 1st Senior and are encouraged to do so. ASC encourages families to join at the same time so they can shoot together and attend the orientation as a family.

1. All prospective members must complete an application regardless of age.
2. **2nd SENIOR** and **JUNIOR** applicant's forms must include a waiver form that is certified and signed by the **1st SENIOR** member of the household.

I also understand that after I am no longer a resident dependent or turn 25 years old, I must become a **1st SENIOR MEMBER** by paying **1st SENIOR MEMBER** annual dues and filling out a new application form.
